Leaving a Legacy of Play

Choosing to remember Right To Play in your will or in your estate plans is a powerful and transformational commitment. When you do this, your estate will receive a charitable tax receipt that can lower or even eliminate estate taxes.

Leaving a legacy gift to Right To Play is an important decision, so you should discuss your plans with your family and loved ones, and speak to your financial planner about what type of planned gift might be right for you, and lastly connect with your lawyer for help preparing or revising your will, or adding a codicil.
