Right To Play UK Monthly Giving Giveaway Terms & Conditions

TERMS AND CONDITIONS: MONTHLY GIVING GIVEAWAY

By participating in the **Right To Play UK Monthly Giving Giveaway**, you fully agree and accept these giveaway Terms and Conditions (“**Giveaway T&Cs**”) together with any specific instructions and terms for such Giveaway as may be found on the Host’s website. The Giveaway will be hosted by Right To Play UK (the “**Host**”).

1. PROMOTER

a) The promoters of this Giveaway are:

Right To Play UK, a charity registered in England & Wales with The Charity Commission, Charity Number: 1112404 and Scotland: SC052331. Registered Office: 101 Edinburgh House, 170 Kennington Lane, London, England, SE11 5DP (“**RTP UK**”)

2. ELIGIBILITY

a) The Giveaway is open to individual entrants globally. Companies / organisations are not eligible to enter the Giveaway.

b) Entrants must be **eighteen (18) years of age or over** at the time they sign up to give a monthly donation. Proof of identity may be required. This must be provided on request.

c) Entrants from outside the UK must ensure that their participation (including the acceptance of any prize awarded) is lawful in accordance with the laws of the country of which they are a citizen and/or reside. This Giveaway is void where void under local national laws. The Promoters and the Host shall not be taken to make any representations, express or implied, as to the lawfulness of any individual's participation, or as to any other aspect of the Giveaway.

d) Employees of the Host, RTP, or their family members or anyone else directly involved in administering this Giveaway shall not be eligible to participate.

e) All entries must be made directly by the person entering the Giveaway.

f) By entering the Giveaway, the entrant confirms that all information submitted is true, current and complete.

3. PARTICIPATING IN THE GIVEAWAY

a) Participation in the Giveaway is voluntary. To qualify for a giveaway item, participants must sign up to make a monthly donation to Right To Play UK and maintain their monthly donation for a **minimum of three (3) consecutive months**.

b) Participants can take part by signing up to make a monthly donation through the designated Right To Play UK monthly giving webpage ("Website").

c) Incomplete, fraudulent or duplicate monthly giving sign-ups will not qualify for the Giveaway.

d) The Giveaway is available for a limited time as advertised by Right To Play UK. Participants must complete their monthly giving sign-up during the promotional period to be eligible.

e) No responsibility is accepted for incomplete monthly giving registrations or technical issues which prevent a participant from successfully completing their donation sign-up.

f) Participants who maintain their monthly donation for a minimum of three (3) consecutive monthly payments will become eligible to receive one giveaway item.

g) Eligible participants will be contacted by the Host after their third successful monthly donation has been received to arrange delivery of their giveaway item.

h) The Host will make reasonable efforts to contact eligible participants using the contact details provided when the monthly donation was set up. Participants may be asked to confirm their postal address before their giveaway item is dispatched.

4. GIVEAWAY ITEM

A) Eligible participants who have maintained their monthly donation for **three (3) consecutive monthly payments** will receive one Right To Play giveaway item. Participants may choose either a Right To Play tote bag or a Right To Play football, subject to availability.

b) The Host will coordinate the distribution of giveaway items within a reasonable timeframe following confirmation of eligibility and confirmation of the participant's delivery details.

c) Giveaway items are provided subject to these Giveaway T&Cs. The Host reserves the right to withhold a giveaway item where these terms have not been met.

d) Giveaway items have no cash value, are non-refundable and non-transferable. Items are subject to availability. Where necessary, the Host reserves the right to substitute an item with an alternative of equal or greater value.

e) Participants are responsible for providing accurate delivery information. The Host cannot be held responsible for giveaway items that cannot be delivered due to incorrect or incomplete address details.

5. PUBLICITY

a) Each winner may be asked to provide their consent to participate in reasonable publicity relating to this Giveaway, including but not limited to having their name published and used for future promotional, marketing and publicity purposes in any media worldwide. Each winner has the right to withdraw the consent it has provided at any time by speaking to an RTP UK representative at info_uk@righttoplay.com.

6. PERSONAL DATA

a) By participating in the Giveaway, you acknowledge that your name, address, email address, country of residence and/or date of birth will have been made available to the Host (as set out above).

b) All Personal Data will be held and/or used by RTP UK in accordance with our privacy policy which can be found at <https://www.righttoplay.org.uk/en-uk/privacy-policy/>. We may also use the information you provide to verify your age and identity.

c) By signing up to become a monthly donor, you agree that your Personal Data will be processed in accordance with our Privacy Policy. We would also love to keep you updated about the work of Right To Play, our campaigns and fundraising activities. You may opt out of communications at any time.

7. GENERAL

a) Any entrant must comply with any directions given to him or her by the Promoters including, but not limited to, all relevant laws, rules and regulations.

b) Any entrant who enters or attempts to enter the Giveaway in a manner, which in the Promoters' determination, is contrary to these Giveaway T&Cs or is unfair, fraudulent or unjust to other entrants or is otherwise not in the spirit of the Giveaway (including without limitation tampering with the operation of the Giveaway, hacking, cheating, deception, or any other unfair playing practices such as intending to annoy, abuse, threaten, or harass any other entrants or the Promoters and/or any of its agents or representatives), may be rejected from the Giveaway at the Promoters' discretion.

c) The Promoters may cancel or amend the Giveaway, the items, or these Giveaway T&Cs without prior notice and for any reason, including (without limitation) in the case of a manifest error. Any changes will be posted within these Giveaway T&Cs.

d) The Promoters cannot guarantee that the services relating to the Giveaway will be free from errors or omissions nor that they will be available uninterrupted and in a fully operating condition. Without limiting clause 7(c), the Promoters reserve the right to modify, cancel, terminate or suspend the Giveaway in whole or in part, at its sole discretion, if it believes the Giveaway is not capable of being conducted as specified in these Giveaway T&Cs or in the event of system failure, maintenance or repair, network issue, a virus, computer bug or unauthorised human intervention or any other cause that is beyond the reasonable control of the Promoters that could corrupt or affect the administration, security, impartiality, or normal course of the Giveaway, including, but not limited to the unavailability of the vote, poll, competition or Giveaway entry platform before the closing date, or for strike, lock-out, labour dispute, illness, act of God, natural disaster, adverse weather conditions, war, riot, civil commotion, accident, epidemic or pandemic, malicious damage, fire, flood and/or storm, compliance with law or governmental order, rule, regulation or direction, breakdown of plant, machinery or transportation. The Promoters are not responsible for any loss or damage caused to you as a result of any of these occurrences.

e) The Promoters will not be liable to you for any loss that is not foreseeable, and the Promoters exclude their liability to the maximum extent permitted by law. Nothing in these Giveaway T&Cs shall limit or exclude liability for death or personal injury as a result of the Promoters' negligence, fraud or fraudulent misrepresentation or for any other liability which may not be excluded by law.

f) Participants must maintain an active monthly donation until at least three (3) consecutive monthly payments have been successfully collected. If a monthly donation is cancelled, fails, or is refunded before this point, the participant will no longer be eligible to receive a giveaway item.

g) The invalidity or unenforceability of any provision of these Giveaway T&Cs shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these Giveaway T&Cs shall otherwise remain in effect and shall be construed in accordance with their terms as if the invalid or illegal provision were not contained herein.

h) The Giveaway and these Giveaway T&Cs will be governed by English law, and any disputes will be subject to the exclusive jurisdiction of the courts of England and Wales.
